- Uniboard provides a limited warranty of 10 (ten) years on the substrate.
- We warrant that under normal use and servicing and when used in accordance with the specifications supplied by us, NEXOS Exterior Panels will be of merchantable quality and will substantially conform to the features in our specification sheet.
- If our product does not comply with the above, Uniboard will, at its discretion, repair or replace any defective product according to the table below. Repair or replacement is subject to sufficient evidence of the defect having been provided. Uniboard shall not be held liable under this warranty if its testing and examination discloses that the alleged defect was non-existent or was caused by the purchaser's or third party's misuse or mishandling. The liability of Uniboard will not exceed the original purchase price of the Nexos panel only.
- Repaired or replacement panels are warranted for the longer of the balance of the original product warranty or 90 days.
- NEXOS Exterior Panels are moisture resistant. Ground contact is not recommended as this may damage NEXOS Exterior Panels.
